Public Hearing - June 19th

The Board of Directors set a public hearing for **June 19, 2024, at 7:00 pm** ("Regular Board Meeting"). The Board Meeting will be held at the District Office located at 8930 Placer Road, Redding, CA. Please refer to the posted agenda for the most current meeting information. At the public hearing, the proposed rate adjustments will be presented and the public will be given an opportunity to comment. **If adopted, the proposed changes will become effective July 1, 2024.**

The following is a summary of the recommended adjustments:

- * **A \$2.00 increase is proposed to both the current Base Rate and Water Availability Charge (WAC).**
- * **A \$.05 increase is proposed to the Consumption Rate.**
- * **A \$2.50 increase is proposed to the Zone A Base Rate Surcharge.**
- * **A \$.03 increase is proposed to the Zone A Consumption Surcharge.**

AlertShasta

Register for Shasta County's New Alert System AlertShasta

Shasta County is transitioning to a new emergency alert and public warning system, AlertShasta. CodeRed, will no longer be used. If you have previously signed up with CodeRed and would like to continue to receive alerts, you must register for AlertShasta.

AlertShasta is a significant upgrade and introduces a range of enhanced features to ensure effective communication during both emergency and non-emergency situations. This new public warning system is available for all residents of Shasta County.

All residents are urged to sign up by scanning the QR code with your smartphone. If you would like to register using your computer, visit www.shascom911.com and click on the "AlertShasta" tab near the bottom of the page.

It is important to note, AlertShasta is a product of Genasys that works in conjunction with, but is not the same software as Genasys Protect, formerly known as Zonehaven, implemented last year in Shasta County. For information about Genasys Protect, visit protect.genasys.com, enter your address in the search bar, and make note of what zone you are in. In an emergency, first responders can use this system to quickly notify the public of evacuations and more. Know Your Zone and share the information with your friends and loved ones. We recommend signing up for both notification systems.

ARE YOU READY FOR FIRE SEASON?



Creating defensible space is essential to improve your home's chance of surviving a wildfire. It's the buffer you create between a building on your property and the grass, trees, shrubs or any wildland area that surround it. This space is needed to slow or stop the spread of wildfire and it protects your home from catching fire – either from direct flame contact or radiant heat. Defensible space is also important for the protection of the firefighters defending your home.

Two Zones Make Up the Required 100 feet of Defensible Space:

ZONE 1: 30 feet of Lean, Clean & Green

Remove all dead plants, grass and weeds.

Remove dead or dry leaves and pine needles from your yard, roof and rain gutters.

Keep tree branches 10 feet away from your chimney and other trees.

ZONE 2: 30–100 feet of Reduced Fuel

Cut or mow annual grass down to a maximum height of 4 inches.

Create horizontal spacing between shrubs and trees.

Create vertical spacing between grass, shrubs and trees.

Use Equipment Properly to Keep from Sparking a Wildfire

Mow before 10 a.m., and never on a hot or windy day.

String trimmers are a safer option (vs. lawnmowers).

Never lay hot equipment on dry grass.

The Centerville Education Foundation Committee will reconvene their meetings in September for the new school year. They would like to congratulate all of the graduates and wish you the best!

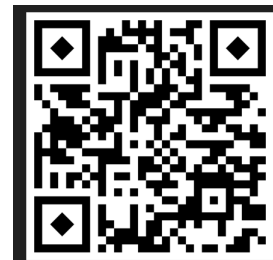
