Board of Directors' Meeting October 19, 2016

Sustainable Groundwater Management Act—Groundwater Sustainability Agency Formation: Shasta County's Director of the Public Works Department addressed the Board of Directors at the October 19th meeting to update them of the on-going activities related to the Sustainable Groundwater Management Act (SGMA) as well as the formation of a Groundwater Sustainability Agency (GSA). According to Mr. Patrick Minturn, SGMA requires that a GSA be formed by June 30, 2017 in order to maintain local control. The Anderson and Enterprise Subbasins are identified as medium priority within the Redding groundwater basin. To date, Shasta County, the cities of Redding and Anderson, the Bella Vista Water District, the Anderson-Cottonwood Irrigation District and Clear Creek Community Services District have been actively coordinating the formation of a GSA to manage these two sub-basins.

While there are small portions within the service boundaries of the Centerville Community Services District that overlie the Anderson Sub-basin, it has been evaluated that the District could not develop a viable municipal groundwater supply within its service boundaries. As such, it was desired by the Board to request that Shasta County represent the groundwater interest within the District's service area which overlie the Anderson Sub-basin.
